The EMD may be submitted in the form of a Fixed Deposit Receipt, or Bank Guarantee from any of the public sector banks or a private sector bank authorised to conduct the government business (At present Axis bank Ltd, ICICI Bank Ltd, HDFC Bank Ltd are three private sector banks authorised to carry out government transactions. EMD is to remain valid for a period of forty five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without

	any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required from firms which are registered with central control purchase organization, DGS&D, NSIC and Department/ministries of Govt. of India for the same item/range of products/goods or services for which tender has been issued. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender.
